MortgageProtectionStore.com Does Not Sell the Information You Provide

- We're not in the information selling business. We think that a local state licensed agent is best able to serve homeowners who are seeking ways to plan out how to protect their mortgage in case of a tragedy. We want you to be able to access a real live person whom you can meet if you choose to do so.

MortgageProtectionStore.com Does Not Gather Personal Identifying Information Unless You Provide It

- We do not collect personally identifying information when you search the site. You must provide your name, address, email and phone when you want to be contacted by your local agent.

How MortgageProtectionStore.com Keeps Your Information Secure

- MortgageProtectionStore.com strives to keep your personal information secure by encrypting all information submitted through our site by using 256-bit Secured Sockets Layer (SSL) protocol. The encryption is done through the digital certificate is supplied by Godaddy (www.godaddy.com). This SSL protocol places your information in a special code and protects it as it moves through the internet. However, keep in mind that no system is 100% secure... even Fort Knox could be breached. If you don't want to risk your information traveling through the internet, simply call your information in to us and we'll be glad to talk with you over the phone: 888-552-9698.

What Information Will MortgageProtectionStore.com Gather?

- We gather some basic information from you for the purpose of helping you determine which insurance companies and products will help you with your mortgage protection planning. First you enter your state, birth date, gender, smoking status, standard health, amount of insurance, and years of coverage desired. If you request an application, we also request your name and contact information. The information you provide through the site is only stored (using the 256-bit SSL technology) if you request an application.
- We also gather anonymous visitor data using Javascript. This helps us determine what content is useful and thus makes the site more effective (see below).

MortgageProtectionStore.com Uses JavaScript to Help Understand and Improve The Site.

- We gather anonymous visitor data using Javascript to act like a store manager who takes notice that someone came to the store and that they looked around at things they found interesting. Basically, the Javascript code provides anonymous data such as which pages are getting the most attention and which links are being used the most.

How MortgageProtectionStore.com Will Use Your Information

- We use the information you submit to help you plan how to protect your mortgage if a tragedy strikes.
- When you submit a request for application, the information will be passed on to your local state licensed agent who will then assist you in your planning for mortgage protection.
- Unless required by the law, we will not otherwise use your information.

How Does My Information Get To The Insurance Company?

- You have to give the go-ahead to your local state agent to submit your information on a particular policy application, you must also provide your written or electronic signature, and then that information is sent to the insurance company. An application cannot be completed with the information submitted through this website. Applications must be completed over the phone or in-person, and you must verify your application by either a written or electronic signature. Without it, the insurance companies won't accept the application.

What Does The Insurance Company Do With My Information Once I Authorize The Agent To Apply?

- They use it to qualify you for the insurance for which you are applying. You must review and provide an electronic or written signature authorizing the insurance company to use the information you provide on the application for underwriting the application/policy (a review process that determines if you qualify for a particular product). You must authorize and sign the disclosures included with your application giving the insurance company permission (if they seek it) to request (where permitted by law) medical and/or driving records, and credit information from a third party. Each carrier determines your eligibility and rates based on their particular criteria for underwriting and each may place different values on the information you supply...in other words they don't necessarily charge the same rate.

What If I Don't Want My Contact Information To Be Passed On To A Local State Licensed Agent?

- Any information you provide through the site is a voluntary choice you make. You do not need to submit information through the site to obtain a cost comparison. You may always contact us directly: by email, phone or by post. If you do not want us to contact you, or pass your information on to your local state licensed agent, do not submit your personal contact information through this site.
